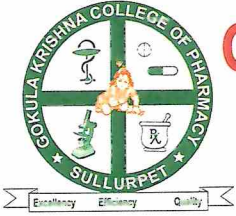

The principal is pleased to present the annual e-governance report for GKCP for the academic year 2022–23.

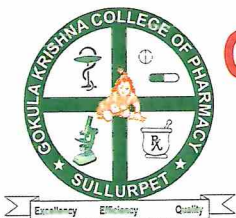
The institution has successfully integrated e-governance across various operational domains, including Administration, Finance and Accounts, Student Admission and Support, and Examination processes.
