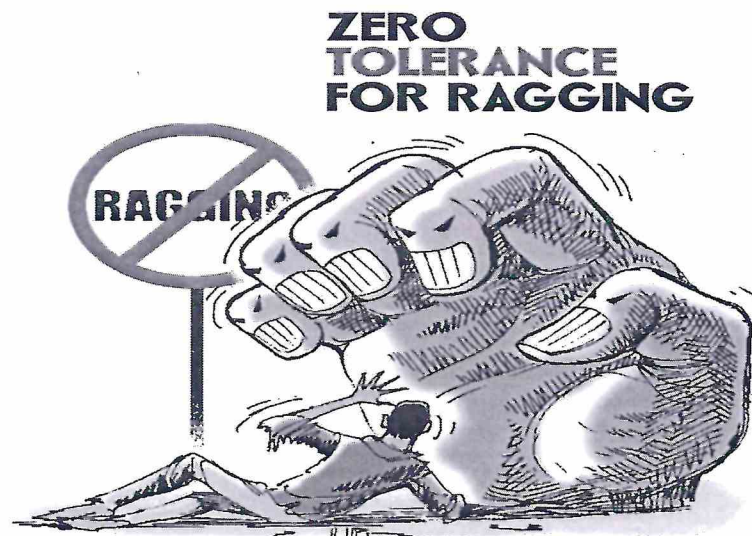
## ANTI-RAGGING COMMITTEE

Ragging is a disturbing reality in the higher education system of our country. Despite the fact that over the years ragging has claimed hundreds of innocent lives and has ruined the careers of thousands of bright students, the practice is still perceived by many as a way of familiarization and an initiation into the real world for young college-going students.

Ragging is a criminal offence as UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit and prevent and eliminate the scourge of ragging. In pursuance to the judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in civil appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on curbing the menace of ragging in higher educational institutions, 2009". These regulations are mandatory for all universities/institutions.

In accordance with Supreme Court judgment and directions, UGC guidelines and directions and State government instructions, Anti Ragging Committee was instituted at Gokula Krishna College of Pharmacy, Sullurupeta.

### Preventive measures:

- ① It was decided to give wide publicity among the students on AICTE/UGC/PCE/INTUA regulations on various anti-ragging acts, rules and punishments through display boards, pamphlets, etc.

- ② Formation of various committees to monitor the students. [Various committees were ~~per~~ formed in the earlier meeting held on 02-07-2018].
- ③ First year teaching staffs were asked not to leave the class until the next class teacher arrives.
- ④ First year classes should be conducted in ground floor nearer to the principal chamber for close observation.
- ⑤ Faculty members are advised to monitor the students during transportation i.e college bus.
- ⑥ Should have a close observation in some places like bus stands, canteen etc. where the seniors will have scope to mix with their juniors.
- ⑦ In hostels (boys/girls) the ground floor will be reserved for the 2<sup>nd</sup> year students.
- ⑧ Complaint box should be placed near by the 2<sup>nd</sup> year class room.
- ⑨ The anti-ragging core committee members should be easily accessible to the students.

- ⑪ Outsiders are not allowed into the campus and hostel premises.
- ⑫ Any form of introduction or ragging by the senior students is not allowed.
- ⑬ Adequate publicity should be given to negative aspects of ragging through print and electronic media.
- ⑭ Security members are informed to have close watch on seniors and outsiders at main entrance.
- ⑮ Hostel wardens are informed to maintain the complete contact details of the students.
